AT THE LITTLE JENNIE RANCH IN BONDURANT, WY

The Inspire a Kid Camp at the Little Jennie Ranch offers an overnight camp experience for male students ages 13-16. The camp will focus on exploration of nature, introduction to conservation principles, leadership development, and learning new recreational outdoor activities while giving participants experiences to successfully navigate and positively interact with the outdoor environment. These camps led by the Little Jennie Ranch and WYldlife Fund staff will allow participants to observe the natural world, engage in wildlife, fish, and habitat biology, and recreate responsibly in the outdoors. Participants will need to bring proper clothing and footwear for outdoor exploration. Meals will be provided for the duration of the camp.

## COVID-19

We want to make all camp participants aware of the modifications and protocols that may be implemented during our 2022 summer camp programs. Camps will be abiding by the current Governor's recommendations and local variance orders for the safety of participants. These following may be implemented for the safety of participants and staff:

- Masks will be optional
- Camp participants will be asked to wash or sanitize their hands before and after eating, after using the restroom, before and after touching any camp equipment and after each camp activity using restroom sinks or provided hand sanitizer.
- We will be sanitizing common spaces frequently.
- If symptoms are detected or reported by any camp staff or participant, the sick person will be asked to take a provided COVID test and be quarantined in their cabin until results are received. Emergency medical care will be sought if necessary. If necessary, the remainder of the camp may be cancelled. All camp staff and participants who interacted with a participant or staff member who tests positive for COVID-19 will be notified and expected to self-isolate at home in accordance with CDC recommendations.

## ARRIVAL AT CAMP

Please plan to arrive by 5:00pm on June 22, 2022

Pick up/leave time at the end of camp will be at 12:00 pm on June 28, 2022.

This iconic working cattle ranch—located a short drive from the vibrant town of Jackson—encompasses the perfect combinations of natural grandeur and peaceful seclusion. Defined by the soaring mountain peaks and surrounding Bridger Teton National Forest. The ranch and its surroundings are a vast outdoor playground with seemingly endless recreational opportunities. Miles of Dell and Jack creeks, boundless fisheries for Cutthroat trout, flow through the ranch. Herds of elk, moose, Rocky Mountain Bighorn Sheep, and mule deer roam the vast parcel, creating an outdoor paradise.

## DIRECTIONS TO CAMP

Camp is located at 332 Dell Creek Road Bondurant, WY 82922

The camp address is searchable on Google Maps for directions as well.

From the Jackson Town Square

Head west on W. Broadway Ave U.S. 189/191/26 South and proceed approx. (13.3) miles. At Hoback Junction, enter the roundabout and take the 2nd exit US-191/US-189 South. The sign will say to Pinedale. Proceed approx. (18.2) miles. Dell Creek Road will be on the left approximately 2 miles after you come out of the Hoback river canyon. It is not well marked. Turn left onto Dell Creek Road. If you pass the Elkhorn Gas Station on the right you've missed the turn off for Dell Creek Road. After 3.3 miles, turn right to cross the creek bridge toward ranch HQ.

## OTHER CONSIDERATIONS

There is no cell phone service at camp, and participants are welcome to bring their cell phones to camp but they will be expected to stay put away/in their bags unless they are being used to take photos at appropriate times. There will be Garmin In-Reach devices available for emergency use. Parents can reach the camp facilitator at [chris@thewyldlifefund.org](mailto:chris@thewyldlifefund.org) / 307-316-3863. Chris will check email and voicemail at-least once per day and will respond as soon as possible.

If your child has special dietary concerns, please be sure they are listed in the registration form so that our camp cook can accommodate.

The solitude and tranquility of our Jack Creek Camp, recently added to the National Registry of Historic Places, are sure to provide an unforgettable backdrop for the Inspire a Kid Camp. Used during the summer season and much of our hunting season, this pristine wilderness in the southern part of the Gros Ventre Mountains is largely untraveled and held in high regard by the locals. This historic site was built by a fur trapper and is adjacent to an ancient Indian trail. Accommodations will be in wall tents and tepee style tents with cots.





# WHAT TO PACK

Camp is located in an outdoor setting in mountainous terrain. The weather at camp can vary greatly, from hot and sunny to chilly and raining, occasionally we have even had snow. Come prepared to be outdoors in all kinds of weather. In Wyoming, the weather changes very quickly. Bring clothes that allow you to dress in layers for both warm and cold conditions...we will continue with our camp activities regardless of the weather unless safety is at risk.

**Please come prepared with the following items. Let us know if you have any questions or if you do not have access to any of the items:**

- Pillow, sleeping bag, or other bedding to sleep on twin-size cots
- Layers: pants, shorts, sweatshirts, thermals, fleece, insulated jacket, gloves
- T-shirts, extra socks, underwear
- Light jacket
- Hats (brimmed hat and warm hat)
- Hiking boots or a sturdy pair of closed-toe gym shoes
- Water shoes / sandals that strap to your feet
- Towel and washcloth
- Toiletry articles (tooth brush, tooth paste, chapstick, lotion-in ziplock bag)
- Sunscreen & Mosquito repellent
- Day pack/ backpack for hiking
- Personal medications
- Swimsuit or other water clothes (*for showering*)
- Sunglasses
- Book

## **Other suggested items (not required):**

- A wrist watch
- Playing cards

**WHAT NOT TO BRING:** Our goal is to maintain the utmost safety for every person at the conservation camp. Therefore, if an item seems like it may challenge the safety of any person or property, it should not be brought to camp. Examples include: Pocket or regular knives, lighters, firearms or ammunition, alcohol, illicit or prescription drugs not prescribed to you, tobacco (in any form), fireworks or other explosives.

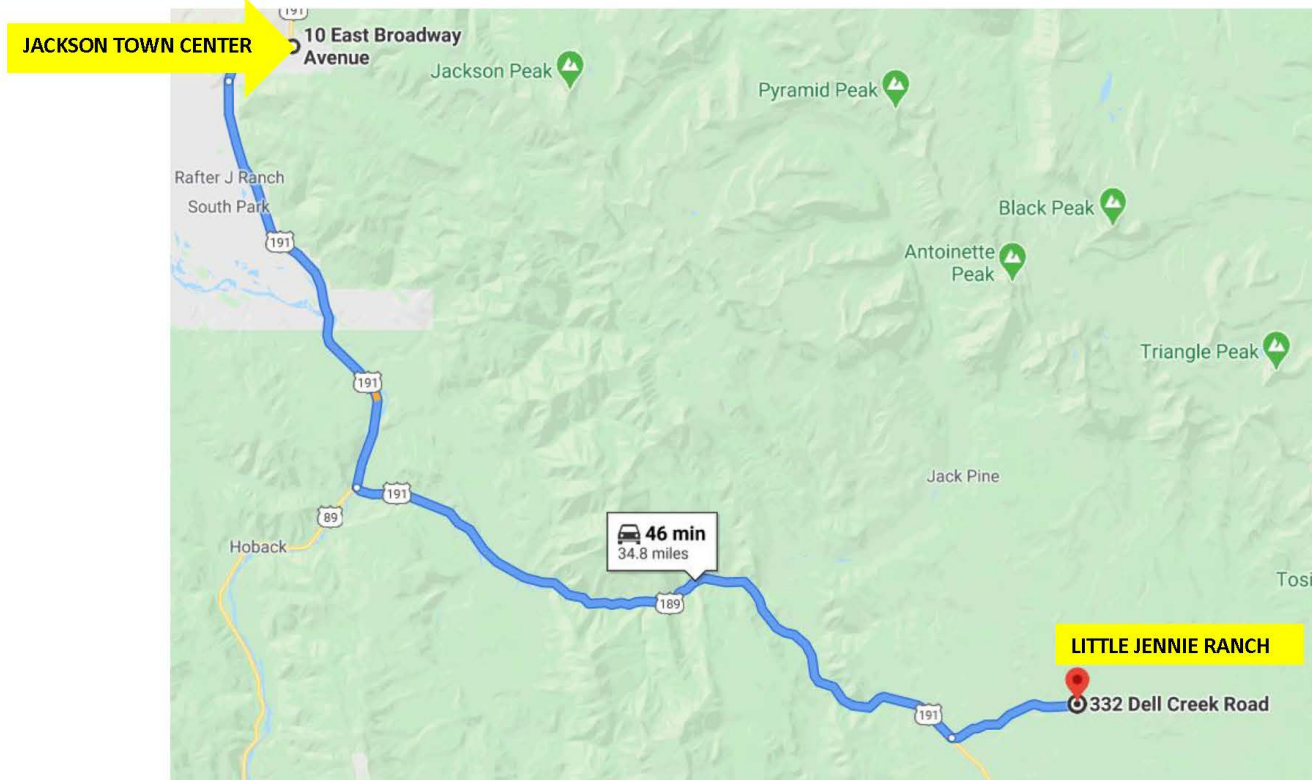

# Inspire a Kid Camp

## Code of Conduct and Behavior Expectations

The WYldlife Fund (TWF) and the Little Jennie Ranch expects youth participants to behave in an acceptable manner at all times in accordance with the TWF Behavioral Expectations and the Code of Conduct Policy.

### Behavioral Expectations

The Inspire a Kid Camp is designed to provide youth with a positive environment in which to learn and grow. It also provides opportunities for youth to build positive life-skills and conservation ethics. TWF supports good character ethics throughout their Inspire a Kid Camp; Camper expectations are that they will demonstrate Trustworthiness, Respect, and Responsibility while attending Camp to assure that all youth have equal access to a positive learning environment. TWF and Little Jennie Ranch staff and volunteers also agree to abide by these expectations of behavior.

As an Inspire a Camp Participant, I agree to comply with these standards of behavior: **Standards of Behavior:**

- To show respect to self, others, the facility, and the environment.
- To be responsible and accountable for actions & choices towards self and others.
- To share equally in group responsibilities and be fair in all activities.
- To perform equal to your academic ability.
- To not use profane, obscene, or abusive language.
- To possess no weapons of any kind (including knives, lighters, firearms, explosives)
- To abstain from using alcohol, illegal drugs or tobacco in any form.
- To exhibit no violent behavior, chronic misbehavior or actions that result in an unsafe situation.
- To abstain from exclusive relationships or sexual behavior.
- To abstain from chronic or unsafe non-cooperation
- To the appropriate and respectful use of cell phones and digital cameras.

### Code of Conduct Policy

If I do not abide by the items named in the Behavioral Expectations, I will experience the following consequences in the order listed:

1. The loss of rights and privileges at the event.
2. Notification of law enforcement as required by the infraction (ie underage possession of alcohol or drugs).
3. Being dismissed from Camp. Notification of my parents/guardians will occur and I will be sent home at my own expense prior to the conclusion of the activity.
4. The possible forfeiture of future participation in TWF Youth Events. If this step is considered, Camp staff, TWF supervisors, and the parents/guardians of the involved youth(s) will make input and determination.

GENERAL RELEASE OF LIABILITY AND MEDICAL CONSENT AGREEMENT  
FOR MINOR CHILD

**ALL parents/guardians of participants must sign this release.**

I hereby certify that I am the adult parent or guardian of \_\_\_\_\_, a minor child under the age of eighteen years, and I have the authority to execute this General Release of Liability and Medical Consent Agreement for my minor child. I consent to my minor child's participation in the activities at the Inspire a Kid Camp at the Little Jennie Ranch in Bondurant, Wyoming. I agree to release, hold harmless, and waive all claims against the WYdlife Fund, a Wyoming nonprofit corporation, the State of Wyoming, the Wyoming Game and Fish Commission, the Wyoming Game and Fish Department, and their respective officers, agents, servants, volunteer instructors, and employees ("Released Parties") from any and all liability or cause of action arising out of any personal injury or death, or any damage or loss of property, and any other loss, damage, or expense of any kind arising out of my minor child's participation in the Inspire a Kid Camp at the Little Jennie Ranch in Bondurant, Wyoming. I acknowledge the Released Parties will not be responsible for, nor legally liable for, any damage or loss of property or bodily or personal injury or death suffered in conjunction with any activities associated with the Inspire a Kid Camp at the Little Jennie Ranch in Bondurant, Wyoming, regardless of fault. I further recognize that the Released Parties retain sovereign immunity as provided pursuant to Wyoming law.

I acknowledge that there are inherent risks of physical injury or illness to Inspire a Kid Camp participants, and I agree to assume the full risk for any personal injury or death associated with my minor child's participation in the Inspire a Kid Camp, and I waive and relinquish any and all claims for personal injury or death, or any damage or loss of property, and any other loss, damage, or expense of any kind that my minor child, my insurer, or my minor child's estate may have or which my minor child may have or which may accrue to said child on account of his/her participation in the Inspire a Kid Camp, including but not limited to inherent risks of any sport or recreational opportunity as defined pursuant to the Wyoming Recreation Safety Act, Wyoming Statutes §§ 1-1-121 through 1-1-123.

I consent to my minor child receiving first aid and other emergency medical treatment in the event of an injury or illness incurred during my minor child's participation in the Inspire a Kid Camp, and I waive and relinquish any and all claims for any personal injury or death, or any damage or loss of property, and any other loss, damage, or expense of any kind that I, my insurer, or my minor child's estate may have against the Released Parties arising out of such treatment. I give permission for the Released Parties to seek emergency medical services for my minor child, should he/she become injured or ill during his/her participation in the Inspire a Kid Camp, with the understanding that I am responsible for any expenses incurred. I understand that the Released Parties do NOT provide any medical insurance coverage for minor children participating in the Inspire a Kid Camp.

I further understand and agree that my minor child must abide by the general rules and conduct prescribed for the Inspire a Kid Camp, and that violations may result in a denial of privileges, a forfeiture of all fees paid, and immediate removal from the Inspire a Kid Camp and the Little Jennie Ranch.
